

PARTNERSHIP AGREEMENT TO PROVIDE ARMY ROTC INSTRUCTION TO STUDENTS OF Lansing Community College

This agreement is between the governing institutional authorities of Michigan State University (after this known as Institution A) which hosts an Army ROTC Detachment and the governing authorities of Lansing Community College (after this known as Institution B) which does not host an Army ROTC unit. It is the sole purpose of this agreement to make the Army's ROTC military science courses available to qualified students of Institution B.

AGREEMENT

1. The Professor of Military Science of Institution A will:
 - a. provide instruction in military science to any qualified student from Institution B who enrolls in the Reserve Officers' Training Corps on the same basis as students of Institution A.
 - b. provide to students of Institution B the following minimum number of contact hours of academic instruction in military science:
 - (1) Military Science I - one hour per week - earns 3.00 credit hours from Institution B
 - (2) Military Science II - one hour per week - earns 3.00 credit hours from Institution B
 - c. in addition to the required classroom hours, provide one hour of leadership laboratory instruction per week.
 - d. provide, at no cost to the student, required textbooks to those enrolled in military science courses.
2. The governing institution authorities at Institution A will:
 - a. authorize the Professor of Military Science to conduct Army ROTC instruction to students enrolled from Institution B.
 - b. accept any qualified student from Institution B on the same basis as students who are enrolled at Institution A for instruction in military science and enrollment as cadets in Institution A's Reserve Officers' Training Corps unit .
3. The governing institution authorities at Institution B will:
 - a. accept the grades awarded by the Department of Military Science at Institution A for inclusion in the student's official grade record and grant appropriate academic credit applicable toward graduation for successful completion of ROTC courses. The following academic credit hours will be awarded toward a student's degree plan for the indicated military science curriculum:

Course Description	Semester Credits
Military Science 101 - Leadership: The Military Profession	3 credit
Military Science 102 - Leadership: Wilderness Survival	3 credit (prerequisite MS 101)
Military Science 201 - Leadership: The Military Leader	3 credit (prerequisite MS 100 level courses)
Military Science 202 - Leadership: Land Navigation	3 credit (prerequisite MS 101, 102, and 201 courses)

b. include in appropriate publications, e.g., school catalog/information bulletin, announcement of military science courses available to its students as credited course offerings.

c. provide the facilities and space required on its campus during the registration period to accommodate ROTC staff personnel. Students register at Institution B only. Registration dates to be determined.

d. appoint one of its staff as an ROTC liaison to assist in coordination of Army ROTC activities.

4. It is understood by both Institutions A and B that:

a. The Reserve Officers' Training Corps program will be administered by the Professor of Military Science at Institution A under the guidance and direction of the assistant provost of Institution A, the senior vice-president of Institution B, and the regulations established by the Department of the Army.

b. Membership in the military affiliated student organizations and other professional development and enrichment activities will be open to all qualified military science students regardless of which institution they are attending.

c. Three and two year ROTC scholarships are available on an equal, competitive basis to qualifying freshmen and sophomores of either institution. These scholarships pay to the cadet all tuition, up to \$450 for books and lab fees, and a subsistence allowance of \$150 per month.

d. Military science will not be offered during the summer semester.

e. Students enrolled in military science at Institution B are responsible for making their own arrangements for transportation to and parking at Institution A for those ROTC activities requiring their attendance.

f. ROTC instructor personnel from Institution A will present the scheduled MS I and MS II courses on the campus of Institution A.

5. Institution B agrees to withhold the grades and subsequent enrollment of any student enrolled at Institution B who fails to return any portion of the uniform.

6. This agreement may be revised or amended any time upon consent of the signatories or their authorized representatives. Further, this agreement may be terminated unilaterally by either of the signatories with at least one year's notice. Termination of this agreement shall not affect the semester in progress or the grades and credit hours to be granted for that semester.
