

ARTICULATION AGREEMENT
Between
The Robert B. Miller College
And
Lansing Community College

THIS ARTICULATION AGREEMENT (hereinafter "Agreement") is entered into by The Robert B. Miller College, a Michigan upper division private institution of higher education, located in Battle Creek, Michigan (hereinafter "Miller College") and Lansing Community College on this 17th day of March, 2010.

RECITALS

WHEREAS, Miller College is a private college with its main campus located at the Mawby Center in Battle Creek, Michigan; and,

WHEREAS, Lansing Community College is a Michigan public community college with its main campus in Lansing; and,

WHEREAS, Miller College and Lansing Community College desire to collaborate to provide opportunities for continued education to Lansing Community College graduates at Miller College.

AGREEMENT

NOW THEREFORE, the parties, desiring to articulate the nature of their collaboration, hereby agree to the following terms:

1. Lansing Community College students who have earned an associate degree or at least 30 hours of credits (at the 100 level) may transfer all credits to Miller College. If a student has accumulated at least 30 hours of credit, but not an associate degree, the credits will be accepted for those courses completed with a grade of C (2.00 on a 4.00 GPA scale) or better. In a course completed on a Pass or Fail basis, only the Pass grade will be accepted in transfer.
2. Miller College and Lansing Community College establish their own admission requirements and recognize and respect the autonomy of each institution. Although qualified students from Lansing Community College may meet the academic admissions requirements at Miller College, such qualified students may be required to meet additional admission requirements related to GPA and prerequisites to some schools at Miller College.

3. Miller College and Lansing Community College recognize that Miller College may refuse admission to any person who does not meet all admission requirements set forth by Miller College. Miller College does not guarantee admission to specific programs for students who meet the standards of general admission to Miller College.
4. Miller College or Lansing Community College may terminate this Agreement by providing the other party with written notice, by first class mail, of the termination of the Agreement. The Agreement shall terminate not less than one hundred eighty (180) days from the date of the termination notice, unless otherwise agreed in writing by the parties.
5. This Agreement is intended solely for the mutual benefit of the parties hereto, and there is no intention, express or otherwise, to create any rights or interests for any party or person other than Miller College and Lansing Community College. Without limiting the generality of the foregoing, no rights are intended to be created for any student, qualified students, as defined here, parent or guardian of any student, or prospective employer of any student.
6. No amendment or modification to this Agreement, including any amendment or modification of this paragraph, shall be effective unless the same is in writing and signed by the party to be charged.
