- c. Senator Mindy Wilson: Is this an LCC backed project?
- d. Michelle Curtin: Yes, Sally Welch was in the executive meeting.
- XI. Update from Soar (engaging a national student success network): Discussion
 - a. See Soar Summary.
 - b. Not moving the needle in certain areas, example diversity. Seeing this over and over in program review. Systemic issue. We need to make change with a sense of urgency. Looking at an external network to help us for the future.
 - c. Senator Matt Van Cleave: What is the cost? Hard to imagine weighing in without knowing the cost. If what we care about is the outcomes, that's what matters. Not saying we are doing this with this organization.
 - d. Senator Michelle Curtin: We won't know until we choose one. Board of Trustees is likely to support an outside source. Can we get behind it?
 - e. Senator Megan Lin: Worked on ATD and G2C. G2C was 6 years. Would be helpful for a discussion like this would be to look at improvement for the classes. 3 years seemed too long for G2C
 - f. MAHE President Eva Menafee: Spent so much money on G2C and it stopped. Spent so much money on ATD and it stopped. If we are going to do G2C we need to not stop. Have to quit stopping.
 - g. Senator Monica Del Castillo: Sometimes it feels like the flavor of the month. With new leadership usually comes new programs and initiatives. We take 0 time to analyze and assess how these programs are working. We implement them without knowing the impact. Expertise on campus not getting utilized.

- h. Provost Sally Welch: There is a difficulty in how do we achieve equity in the classroom? Faculty tend to leave this blank on Program Review. So can we go outside of us.
- i. Faculty Jim Luke: We are in a new world. Social justice issues are very different. Why do we think a lot of outside experts know? ATD is retired CEOs and Provosts, who haven't designed things in 10 years. Faculty are exhausted to go even further. That will have an impact on students. There is no base for this. If you want to do this, narrow down the goals. Track record is that we don't include our internal experts. We have done nothing to change organization structure. More layers of management. Cost is a big issue. Hidden cost and opportunity cost. CTE had employees cut in half.
- j. Senator Veronica Wilkerson-Johnson: Could a gathering be assembled, a Team, to look at the external ideas as well as internal.
- k. Senator Leslie Johnson: Troubled by the fact we need to bring in experts. When faculty it comes to equity issues, faculty see the problem in the eye. Problematic when closing faculty out of the issue. What do faculty needs and what specific resources are needed. Faculty are already on this in various groups. Process needs to change. Instead of coming on high, needs to come from classroom.
- I. Senator Denise Warner: Why do we go to national or international conferences? To learn from others. Get a window into other colleges. Could be more beneficial if brought together instead of piecemeal. Expertise might be able to bring everything together in a cohesive way.

- d. Senator Bill Garlick: Get something out sooner for preferred pronoun. Student affairs has worked on a form for students to fill out. During the fiscal year we have had two product purchases that help enable preferred pronoun.
- e. Senator Kabeer Ahammad Sahib: Why do we have to have preferred name and then official name in D2L. Instructor only knows preferred name in D2L would

- avoid a lot of confusion. Only preferred name in D2L would be easier on instructors.
- f. Senator Bill Garlick: Preferred name should override legal name in D2L so there should not be confusion. End Goal there will be no two names, it will only be preferred name.
- g. Senator Sarah Garcia-Linz: We no long have the ability to edit names in WebEx. We should look into this.
- h. Senator Bill Garlick: Will bring this back to IT leadership to figure this out. 1 as we are logging in as an LCC employee it will grab our legal name. Once preferred name is finished it should be automatically bring in preferred name. 2. If you are logging into a meeting or joining a meeting, you can change your name.
- i. Senator Leslie Johnson: How are we going to roll this out to faculty and train faculty.
