#### VIII. Standing Committee Reports

- a. Budget Committee Senator Marv Argersinger
  - First, we would like to introduce our newest Budget Committee member, Chelsea Brandon. Thank you for joining our committee, we are glad to have you part of our committee.
  - ii. Since our last Academic Senate Report, the Budget Committee has been busy determining how well we are aligned and doing the work that our charter outlines for the committee.
  - iii. The Provost, Sally Welch attended our October 18, 2024 meeting to discuss how the budget committee can become more involved in the budget process across the college and better meet the charges of the committee's charter. Several different ideas were discussed during this meeting. One area is how we could help faculty become more involved in the program operating plans. The program operating plans are direct input of the programs needs to their administration, whether it be funding for equipment, budget needs, staffing and faculty needs. This is the best and most direct way for programs to communicate its needs.

The program operating plan is a living document and can be updated anytime. Thank you Sally for taking the time to attend our meeting, answering questions and give us guidance where the committee should go.

- iv. Karen Tommasulo also attended a committee meeting to discuss the possibly of implementing the "Sizzling Budget Topics," an informational document similar to "Hot Topics" the senate sends out. We thought this would also be a good way to distribute budget information to senate members, to then distribute to their constituents. Thanks, Eva, for the idea.   - ii. Senator Tanya McClain Students already struggle in math, don't want to put up another barrier. Need the right tools to do your job.

- iii. Senator Dustin Abrego When students pay tech costs, could this be factored in?
- iv. Senator Eliza Lee Is there a buyback program? 2000 students a semester take math but only 200 are really math majors so not many need them
- v. Senator Rick Caprario Is there an online calculator?
  - 1. Senator Eliza Lee Yes but cannot use that for assessments.
- vi. Senator Gerry Haddad Could the math faculty have the calculators? Give them 30 each?
- vii. Dean Ronda Miller Is there a problem returning calculators to library?
  - 1. Senator Chuck Page Not personal experience but hear that there are.
- viii. Senator Ed Kabara Can students use their cell phones with the TI App on it?
  - 1. Senator Eliza Lee- Equity problem with letting students use cell phone. Also, would be afraid of cheating. Not allowed on assessments or in the Testing Center.
  - 2. Senator Dustin Abrego Also don't assume all students have cell phones, we don't want to put up more barriers.
  - 3. Senator Homa Gaussi Mujtaba Don't like the idea of cell phones. Like the buyback program.
  - 4. Faculty Dawn Hardin Experience with students that having used a cell phone is very different than using a graphing calculator.

    May have an accessibility problem using the cell phone.

- X. Admin Senator Expectations Senator Jessica Hester
  - a. Senator Jessica Hester came from an institution that had a faculty senate that did not include administrative senators. Senate is about collaboration. Want to begin the conversation. "What is the Senate's expectation of administrative senators?"
  - b. Senator Mark Kelland It was helpful to point out to HLC a part of shared governance is the Academic Senate. Having admin attend gives support to the Senate. Want administrative senators actively involved in discussions.
  - c. Senator Jessica Hester Nice to say same as all other senators. But appointed not elected, don't come in the same time, and don't have the same orientation.
  - d. Senator Joann Silsby Important to have different levels because some levels are privy to more information. The more heads the better.
  - e. Senator Eliza Lee Moving orientation to Spring with elected senators so administrations feel comfortable joining Academic Senate. Also want administrative senators to feel comfortable to speak in meeting.

- f. Student Senator Aral Gribble Often barriers come from admin, know the Academic Senate is trying to bring down barriers. Goal is in the senate is for student success, so don't feel power dynamic.
- g. Senator Autumn Brown Being new, don't feel power dynamic. Feel the faculty have been able to speak without fear.
- h. Senator Mark Kelland Willing to speak for others, willing to take their written statements.

# Appendix I

## The Unmet Need for Graphing Calculators

1) One or more of these mathematics or statistics courses are required for almost every Associate's Degree. The TI-83/84 graphing calculator is required in all math and statistics classes.

Information copied from the Materials section of the Concourse Master Syllabi Fall 2024:

- Math 115: A graphing calculator is required. The TI-84 Plus CE is highly recommended.
- Math 119: Graphing calculator required; TI-83/84 series calculator highly recommended.
- Math 120: A graphing calculator from the TI-83/84 family is required for course work. TI-84 Plus CE is recommended.
- Math 126: A graphing calculator from the TI-83/84 series is required for course work.
- Math 151: A graphing calculator from the TI-83/84 series is required for course work; TI-89 may be used.
- Math 152: A graphing calculator from the TI-83/84 series is required for course work; TI-89 or TI-Nspire (CAS) may be used.
- Stat 170: Graphing calculator required; TI 83-84 series calculator highly recommended.
- Stat 215: A graphing calculator from the TI-83/84 series is required for course work.
- 2) The current price of a TI 84 Plus CE is \$115 and a TI 83 is \$77 on Amazon. Price in local stores tend to be higher.
- 3) The need far exceeds the current availability.

Total Headcount in these courses Fall 2024 was 2140 on the first day of the semester.

# Number of calculators available for check out: Library 110, Adult Resource Center 50

From the Adult Resource Center: All calculators were checked out early in the semester. Many students came asking to borrow a calculator and were told there were none were available. The number of students who asked but there were not calculators available is not tracked.

From the Library: Of the total 110 graphing calculators, 100 are on 28-day checkouts and 10 are on 2-hour checkouts. The majority of the semester all 100 of the 28-day are checked out. The number of students who asked but there were not calculators available is not tracked, however, students are offered a spot on a waiting list for a calculator. The ten on 2-hour check outs are frequently checked out, with usually a few available, but are not always returned within the 2-hour window. In comparison, the Library has approximately 1000 laptops checked out for the semester.

Without a graphing calculator, students are less likely to succeed in their math classes. Instructors explain how to do problems step by step based on the key strokes of the TI 83/84 calculators. There are students in math classes currently without graphing calculators. Not having equal resources as other students in the class significantly reduces the students' sense of belonging. In Fall of 2023, these math classes overall had a 64.3% success rate compared to an overall college success rate of 78.3%. (Data provided by Center for Data Science.)

# Academic Senate Lansing Community College

Resolution on Increasing Availability of Graphing Calculators

Whereas, the college is committed to promoting equitable access to resources essential for academic success for all students; and

Whereas, Graphing calculators are required in many math and science courses and if students are unable to afford graphing calculators, they are less likely to succeed in their courses; and

Whereas, students have expressed the cost of purchasing a graphing calculator is a financial barrier; and

Whereas, the current supply of loanable calculators is insufficient to meet the demand among students who cannot afford to purchase these devices independently and the Library has continually had a waiting list for checking out graphing calculators; therefore, be it

**Resolved,** that the Academic Senate strongly encourages the college to significantly increase the number of graphing calculators available for students to check out in the Library.
