 - iii. Charged by Senate to look at AI detection. It is ongoing. Discussion has revolved around how TAC can support the college and the colleges efforts on AI.
 - 1. How could we at the college help support faculty and students in appropriate use of AI and approach learning from the standpoint of not using AI inappropriately.
 - Realize different departments have different needs with AI. WE
 recognize and applaud the colleges proactive approach to AI.
 Recognize that college-wide one size fits all PD is going to be not
 great.
 - a. Recommend that the Senate and the College support with time and space and financial resources small faculty driven groups to be set up on how AI affects specific programs. Teaching circles etc. could be useful.
 - 3. A lot of the discussions to this point has been focused on writing and the humanities. Concerns of plagiarism and how AI impacts all our writing. Another area is students use AI inappropriately in assessments on timed exams on D2L. Noticing when we move some exams to D2L that aren't proctored during Covid, exam

scores have improved. Students are using AI in these assessments. There are a lot equity issues. If you try to AI proof exams by making them harder, the students that don't use AI are at a disadvantage. So privacy and equity considerations. Do we need more Testing Center space for more proctored assessments? Won't be resolved the same by every department.

XI. AI Examples – Senator Tracy Nothnagel

a. Senator Mark Kelland – Works on OER. Hard to work on an addition to one of his textbooks. Details of black psychology in the United States. Wanted to do

- another addition to Hispanic perspective. Looking to replicate what he already wrote to see if ChatGPT can write at a level that he wrote.
- Senator Tammy McDiarmid Uses it to reword her emails. Been told she is a little direct. She asked ChatGPT to sound more professional and softer.
 Rereading it, it doesn't have a personality. So, you end up changing it and making it sound like you.
- c. Senator Autumn Brown In nursing we have students use AI to make a plan of care for a patient and then they look over it and see how well it met their patients' needs. We identify how it may have been very general and we need to be more specific for our patient
- d. Senator Susan Hardie Uses things like making her emails sound more encouraging.
- e. Senator Louise Rabidoux Incoming counseling Jim Owens has used AI.

 Counseling team has played around with AI on behavior intervention team.

 Making sure we addressing all of our students concerns. Making sure to get feedback to not miss anything or do something differently. Put in POP to see if we can come up with a better template. Heard students use AI for breakup texts and online profiles.
- f. Senator Tedd Sperling Experience Tedd has had with a student. Student showed him the work, realized it was above his skill level. He came back and said he used AI. Told him he had to teach Tedd how to do it. Showed him how to use prompts. Can prompt to do much. Ask his ChatGPT his name and says his name is Sage. Should look to see how AI is going to help you. Programing industry it is doing extremely well. It's inevitable that AI is going to be here.
- g. Senator Tanya McClain Can't escape it. Its online and even at doctor's office. Captures meetings and AI can cover materials that are missed. Used for data research. Can sometimes bring back invalid research.
- h. Senator Dan Mulligan Use it for PowerPoints. Can summarize case studies and suggest questions to ask. In marketing research, we have a semester long project that is a scaffolded number of projects. Has a focus group and explains how a student would execute a focus group. But hard to execute an actual focus group. Have created an AI bot in Chat GPT that ask him to input the profiles of members of the focus group and then the AI bot will role play each of the characters. So, students can execute their focus group plan. Pretty good way of making a focus group simulator.
- i. Senator Chris Richards eLearning is working to integrate an AI tool from D2L to assist with creating course assessments based on an instructor's course content.
- j. Senator Lee Gardner Teaches English. Students remind that examples need to be update. Shows them examples of Derek Jeter, Jenifer Gardner and students don't know what they are. Al can help keep students interests in topics.

- k. Senator Robyn Corey Doesn't use any Al. But very intrigued. Are these paid subscriptions?
 - i. Senator Tracy Nothnagel ChatGPT has limits, like time limits. There are other ones like Gemini, perplexity, CoPilot etc.
 - ii. Provost Sally Welch Implementing a plan that is going to do PD, advanced PD, subscriptions, have consultants coming in, and consider reassign time. An unofficial reveal of the plan on April 21st at 10:10 and over WebEx.

- Senator Jessica Hester AI in the humanities is not appropriate. A lot of it has to do with the writing and analysis of ideas. "Bad writing is reducing the quality of our suffering"
- m. Senator Annescia Dillard Use AI to write session proposals or outlines. Provides with activities and questions as well. A lot of capabilities. CTE can always show you some things.
- n. Senator Tracy Nothnagel Used AI to take her recorded lecture into a Podcast. Was 40 min lecture that turned into a 20 min Podcast. Played recording.
- Senator Dustin Abrego Notebook LM is free. Podcasts use it for summaries.
 Makes an AI voice. Gamma is a PPT creator. Need to be careful what you call "your work" when it is not your work. Ethics of AI need to be discussed.

 Beware, it won't just have implications in the classroom
- p. Senator Rick Caprario Question: If as a college we establish guidelinesexpectations for student use...will we prescribe those same guidelines and expectation of use to the faculty and administration as they perform the essential functions of their jobs?
 - Senator Eliza Lee Last year Adam Richards and Laurie Bishop started Al guidelines for LCC with our Al workgroup. I would contact either of them for more information. Work is ongoing and expect a presentation again soon.
 - ii. Provost Sally Welch Not making anyone us AI. Just want to provide resources. Using the AI workgroups recommendation to come up with LCC headlines. Also encourages teaching students critical thinking and logic outside of AI, that will never go away.

- a. Was here a month ago. Proposed an additional subcategory under ELO 4. ELO 4 is Integrative and Applied Learning. Would like to add a subcategory of Wellness and Fitness under this ELO.
- b. Additional learning outcomes related to wellness and fitness are being considered to balance cognitive learning.
