- a. Quick update on campus project visitor lounge directors' space Lansing airport hangers are no more – made a good deal with Cap city. Green-scape can now be developed for anything. Carrier house – historical society space now there. Pictures to come. Could be us this week for other functions in the future. Long time since this was a functional space. Case credit union will be live and online. Modifications on GB level 3 one of 2 spaces on back of gym – used for athletics and events. Close to getting the new changemaker center completed. High tech screen and high end complex curved screens. Full operation in 2026 – Bruce M has some beautiful art! Cyber security is coming along – see in progress pictures. CIT team will install commissioning of this space. Will be working on the bugs for spring semester. Additional wall graphics – substantially complete and working on technology needs. Transfer center is running later than planned. Several more weeks before in a position to open up the grab and g food court. Permits and projects have held up a with unanticipated delays. Operational in spring 2026. Pizza Hut space will now be student lounge. Reno space will be associated with the transfer center. Cap request – new campus energy and utility and training center. Submitting for project again – to augment service and better learning space at west campus.
