Action Items:

Work on articulating cocurricular and extracurricular activities at LCC – Mark Kelland

- Will need to identify cocurricular activities and have an assessment method for them.
- Have heard LCC’s submitted HLC quality initiative report was just recently sent out by HLC for review.
 - Hope to hear from them soon, Mark will keep us updated
 - Once received may need to revisit current cocurricular work as directed in review
 - Even if worse was to happen and the review shows LCC current cocurricular system as questionable, actions taken now will show work is being done to address the situation
- Heidi, as Chairperson Elect will take the lead on this project.

- Mark and Karen will update her on past work
- Goal is threefold:
 1. ID cocurricular programs that have a learning assessment in place and initiate that assessment.
 2. Help currently identified cocurricular programs without an assessment plan in place create one, and initiate that assessment.
 3. ID other groups that should be considered cocurricular and work with them to create an assessment plan, and initiate that assessment.
 - Note: Attendance sheets do not count as assessments, must be on student learning
- CASL can work with programs on creating an assessment plan, but identified cocurricular programs can also work individually with Karen, LCC's Director of Assessment.
- Original subcommittee established pre-Covid, can start there if desired.

Discuss Using Critical Empathy to Assess Writers' Invisible Learning: Student/Self Annotation – Mel

- Item previously laid on table but picked up in Agenda.
- Melinda (Mel) had shared this article in an email prior to the meeting.
 - It can also be found on the CASL SharePoint in the [Resources Folder](#)
- Melinda shared portions of a presentation she made to her class about this article with the group.
 - She also shared her intention of doing a trial by using the methods discussed when grading her student's final paper this semester.
 - After seeing results will determine if continue in spring
- Main focus is to remind faculty that social factors have shaped their students, and to grade them using the same methods used to grade previous generations is problematic.
 - Faculty should be wary of assessing students using the same social narrative that shaped them
 - Goal of outlined method is to give students hope and agency, reduce their anxiety from perfection and time, while creating an opportunity for dialogue.
 - Uses annotation as a way faculty explains how paper is graded and student can respond before final grade is recorded so that their intentions are known (invisible learning)
 - This is an example of "authentic assessment."
- CASL members thanked her for sharing her article and ideas for practicing them in her classroom.
 - All CASL members are encouraged to share items of interest to them as they relate to assessment – they are welcome agenda items
